How Can Advocacy Help?

- Interact with industry allies & decision makers
- Build and strengthen relationships with congressional allies & federal agencies
- Secure more federal funding for onsite wastewater treatment
- Prevent federal policies from negatively impacting NOWRA members





Accomplishments So Far

- Built credibility for NOWRA
- Strengthened relationships with DC allies
- Enacted provisions of the NOWRA Act
- Added wastewater question to future ACS
- Expanded USDA's Decentralized Water Systems program & increased funding 5-fold
- Developed & enacted EPA's Decentralized
 Wastewater Grant Program





Current Legislative Activities

- Adequately fund EPA's Decentralized Wastewater Grant Program
 - Program is authorized for up to \$50 million annually
 - Currently set to receive \$5 million in FY'23
- Expand USDA's Decentralized Water Systems Grant Program
 - Program is authorized for up to \$20 million annually
 - Set to receive \$5 million in FY'23






Executive Branch Activities





Current State of Play in the Senate

- 117th Congress: 50-50 Democrat majority
- 34 Senate seats up for election: 14 Ds, 20 Rs
- 28 Senators seeking re-election: 13 Ds, 15 Rs
- 6 Senators retiring: 1 D, 5 Rs

- WI—Sen. Ron Johnson



2023 Congressional Activities

- Secure more funding for EPA's new Decentralized Wastewater Grant Program
- Increase funding for USDA's Decentralized Water Systems Grant Program
 - Through FY'24 appropriations process
 - Through Farm Bill reauthorization
- Be positioned to take advantage of legislative opportunities and defend against budget cuts
- Increase outreach and cultivate new allies
