## Project Objectives


- 1) Contact permit authorities of onsite system permits for the years 2015-2018
- 2) Assess Onsite System Utilization Rate (OSUR) measurement  $\frac{New\ OWTS\ Permits}{New\ Housing\ Permits} = OSUR$
- 3) Determine trends and integrate new variables for analysis

- •National Environmental Services Center (NESC) conducted an assessment of onsite wastewater systems in 1993 and 1998.
- •Contacted 3,490 permit authorities with a 45% response rate.

### Response rate of National Assessment



Around 85% of permitting authorities contacted for 2015 data; 45% for 2016- 2018.

## Onsite System Utilization Rate (OSUR)

$$Adjusted\ OSUR = \frac{OWTS\ Permits}{(TNH)\ X\ (NH\%)}$$

OWTS permits are residential or combined (residential and commercial)

Total New Housing (TNH) is the sum of manufactured and constructed housing with a 6-month lag

New Housing Percentage (NH%) is the percentage of new housing located within responding counties.





Unable to parse incompatible data in the historical dataset (1993, 1998) due to data set limitations.


# Onsite System Utilization Rate National Map - 2015




