It is the responsibility of the exhibitor to make arrangments for exhibit materials to be shipped out. Exhibitors must complete the following:

- 1. Pack all materials
- 2. Complete paperwork / bill of landing and provide copies to venue staff.
- 3. Move materials to shipping area designated by venue staff.
- 4. Arrange pick-up with courier company within 48 hours after event.

All shipments must be pre-paid. Any materials not picked up after 48 hours will be shipped at the expense of the exhibitor plus storage fees & service charges.

Terms & Conditions

Payment

Payment in full must be received at least fourteen (14) days prior to the first scheduled event date. Orders received less than fourteen (14) days in advance or without full payment will NOT receive the advanced rate. Unpaid orders will not be installed.

Any additions or changes to orders, advance or on-site, will require payment in full before insillation. Any additional charges for damaged or missing equipment will be billed after the end of the event.

Cancellation Policy

14+ days before Event:	75% of total rental fees
7 - 14 days before Event:	40% of total rental fees
7 or fewer days before Event	Non-Refundable

Rates & Labor

- 1. Rates listed cover supplying vendor booths with service. These rates do not include connection of Vendor equipment to the supplied service.
- 2. Special placement or relocation of service will incure labor charge.
- 3. On-Site orders are limited to available supply and cannot be guaranteed
- 4. All prices are based on current rate and are subject to change.

Intallation, Disconnection, & Use of Service

- 1. Electric service is 120-Volt AC Single Phase 60 cycle or 209-Volt one phase & 208 Volt three phase 60 cycle. 277/480-Volt three phase service is limited by availability. Please contact Sales & Catering Department to inquire about service availability.
- 2. All provided equipment shall remain on premises and only be disconnected by staff members. Standard wall, column, or permanent building outlets are not part of Exhibit Booth Services and are not to be used without the concent of Event Manager.
- 3. Exhibitors will be held responsible for damages to equipment during rental period & any resulting costs for repair. Rental period is to begin upon installation until disconnection.
- 4. Exhibitor equipment must be tagged with complete information about voltage, amperage, phase, frequency, etc. Any exposed non-current carrying metal parts of equipment must be grounded.
- 5. All equipment must comply with Federal, State, and Local safety codes.
